



Photography Guidelines

We know the greenhouse is a popular destination for photography but while our location has a beautiful atmosphere, we are still a private business. Photography sessions can interfere with our day-to-day business. Photo sessions may be scheduled only in the months of **January, February, July, August, September, October, November, and December** due to our growing season in the other months.

Photo Session Guidelines:

- Buchwalter Greenhouse reserves the right to refuse or suspend a session for any reason and to direct where photography will be permitted on the premises.
- Please call ahead to schedule your session. In the event of rain or inclement weather, you may reschedule your session.
- All photo sessions will pay a session fee of \$40 per hour.
- Payment in full must be made by the morning of the shoot. Payment may be made by cash, check or credit card. Appropriate sales taxes will be applied.
- A signed copy of these guidelines and attached application must be returned no later than 24 hours before the scheduled session.
- Photo sessions must be scheduled during our regular business hours. Exceptions will be considered on an individual basis and may incur additional fees.
- Certain times and locations may be unavailable due to several factors including, but not limited to, business cycle, traffic flow, special events, seasonality, and weather.
- Sessions will not be available in March, April, May, and June.
- Photo sessions must not interfere with regular business practices or the enjoyment of other customers, or close access to any area.
- Guests should come dressed and prepared for their sessions. All session participants must be fully clothed while on the property. Lingerie shoots will NOT be permitted.
- Do not disturb or remove plants, containers, garden accents, or any other merchandise to stage a photo.
- Photography sessions must not create any safety concerns for participants, Buchwalter customers or staff. Do not climb on ladders, stand on benches, display pieces or tables or ride on shopping carts
- Photographers are responsible for any damage to Buchwalter Greenhouse property.
- Drone photography is considered commercial photography and requires a scheduled session with applicable fees.
